Subject: Executive Director Search Firm

In September, Executive Director Georgia Lomax announced her plans to retire in early 2022 and the Trustees discussed the potential process and their expectations for starting a national recruitment for Pierce County Library's next executive director.

During the September Board of Trustees meeting you stated you would like to contract with a search firm specializing in library director recruitment that had alignment with the Library's goals and culture as well as experience in recruiting diverse candidate pools.

Bradbury Miller Associates was selected through a competitive proposal process during the 2014 director search. In order to expedite the recruitment process, and based on the Library's experience during the 2014 search, you directed me to vet Bradbury Miller Associates and determine their availability.

I have completed an evaluation of Bradbury Miller Associates and recommend the Board move forward with engaging them for this important work.

During the meeting I will answer any questions and ask for your direction on next steps.

MOTION: Based on the Library's previous experience and in order to expedite the recruitment process, I authorize Staff Experience Director Cheree Green to sole source and enter into a contract with Bradbury Miller Associates to recruit nationally for an executive director for Pierce County Library System.
